

Dollar General is committed to offering for sale only those products that meet or exceed applicable legal and regulatory requirements, including those relating to product and environmental safety. Where practicable and in keeping with the Company's obligation to create long-term value for its shareholders as a whole, the Company will endeavor to go beyond what is required by law and take additional steps to reduce or eliminate certain intentionally added high priority chemicals (the "Chemicals") in and from its private label formulated products (the "Products") in certain departments (the "Departments"). These Chemicals will be posted on its Restricted Substances List ("RSL").

The Chemicals included on the Company's RSL are:

- Bromopropane
- Asbestos
- 1,4-dioxane
- Cyclic Aliphatic Bromides Cluster of Flame retardants (HBCD)
- Octamethylcyclotetrasiloxane (D4)
- Lead and Lead Compounds
- Cadmium and Cadmium Compounds
- Bisphenol A (BPA)
- Diethyl Phthalate
- Dibutyl Phthalate
- Tetrachloroethylene (PERC)
- Butylparaben
- Formaldehyde
- Nonylphenol Ethoxylates
- Propylparaben
- Toluene
- Triclocarban
- Trichloroethylene
- Triclosan

The Departments covered by this policy are:

- Home Cleaning
- Beauty & Personal Care
- Hardware
- Automotive

In furtherance of this Policy, the Company has taken or intends to take the following actions:

- Urge its suppliers to use safer alternatives for the chemicals on its RSL (e.g., those identified by the U.S. Environmental Protection Agency's Safe Choice program)

- Require the elimination of certain Chemicals from certain Products in covered Departments by various dates¹
- Encourage vendors to reduce or eliminate their use of Chemicals in non-private brand products sold to Dollar General
- Enhance information collection regarding the chemical composition of the Products in covered Departments sold to Dollar General, through the expectation that suppliers will register product formulations with the UL WERCSmart® system and provide Dollar General with consent to access and utilize this data
 - Include the expectation of cooperation regarding these efforts in the Company's vendor guidance, as well as in applicable supplier agreements
- Review and evaluate the Products, Departments and Chemicals covered by this policy on an annual basis, referencing information provided by the WERCSmart system
- Encourage suppliers of Products in covered Departments to improve transparency with consumers regarding the ingredients in their products
- Participate in the Chemical Footprint Survey in 2023

¹ The Company committed to removing the following Chemicals from Core Private Brand formulated Products in its Home Cleaning and Beauty and Personal Care departments by December 2022: Formaldehyde, Toluene, Triclosan, Nonylphenol Ethoxylates, Butylparaben, Propylparaben, Trichloroethylene, and Triclocarban. The Company committed to removing the following Chemicals from Private Brands formulated Products in its Home Cleaning, Beauty and Personal Care, and from its Private Brands formulated cleaning products in Hardware, and Automotive departments by January 2024: Formaldehyde, Toluene, Triclosan, Nonylphenol Ethoxylates, Butylparaben, Propylparaben, Trichloroethylene, and Triclocarban, Bromopropane, Asbestos, 1,4-dioxane, Cyclic Aliphatic Bromides Cluster of Flame Retardants (HBCD), Octamethylcyclotetrasiloxane (D4), Lead and Lead Compounds, Cadmium and Cadmium Compounds, Bisphenol A (BPA), Diethyl phthalate, Dibutyl phthalate, Tetrachloroethylene.
